



# Serving His Country and Podiatry

Podiatry's first U.S. Congressman is elected to the *PM* Hall of Fame.

In 2012, Brad Wenstrup, DPM, became the first podiatrist to serve our nation in the U.S. House of Representatives. Elected from Ohio's second congressional district, he is now in his third term.

Rep. Wenstrup has quickly made a name for himself in the halls of Congress, serving on the House Armed Services Committee, the House Committee on Veterans' Affairs, and the House Permanent Select Committee on Intelligence. A veteran of the Iraq War and a colonel in the Army Reserves, he chairs the Veterans' Affairs Subcommittee on Health. He also is a member of the House Doctors' Caucus.

In 2017, Rep. Wenstrup made national headlines for his heroic actions on a baseball diamond in Northern Virginia when a shooter opened fire during a congressional baseball team practice. Rep. Wenstrup used his surgical training and his experience in treating combat injuries to care for Majority Whip Stephen Scalise (R-LA), who was seriously wounded in the incident.

Perhaps nowhere has Rep. Wenstrup made his influence more keenly felt than in his chosen profession of podiatry. His role in the House of Representatives and the coverage of his work have generated goodwill for podiatry, and he has proven to be a formidable advocate for the profession's priorities.

Rep. Wenstrup introduced the American Podiatric Medical Association's (APMA) VA Provider Equity Act

in the House in the 115th Congress and worked tirelessly for its passage alongside APMA members and staff lobbyists, underscoring the importance of providing quality care to veterans.

"It's the weight of the patient that I feel," Rep. Wenstrup told APMA News at the time of his election. "We've got a lot of problems and things we've got to work out. Everyone is concerned about our medical profession as we move forward."

Rep. Wenstrup invited podiatrists to testify before the Subcommittee on Health in 2017, and his office worked closely with APMA Legislative Ad-

vocacy Director and PM Hall of Fame member Benjamin J. Wallner on the strategy for advancing the legislation. "I have the distinct privilege of working with Rep. Wenstrup and his staff on Capitol Hill," Wallner said. "His leadership and commitment to this profession have enabled us to advance legislative and policy goals for the benefit of all podiatric physicians and their patients."

The VA Provider Equity Act passed the House of Representatives on unanimous consent in the summer of 2017. At the time of this writing, it was awaiting consideration in the Senate as part of an omnibus VA bill.

"We've earned [parity] through our education and training," Rep. Wenstrup said. "When I bought a practice in 1986, the retiree was a chiropodist and had his degree three years out of high school. We've really made our names by our [improved] training."

Rep. Wenstrup completed his undergraduate work at the University of Cincinnati and earned his Doctor of Podiatric Medicine degree from the Dr. William M. Scholl College of Podiatric Medicine at Rosalind Franklin University of Medicine and Science. After completing his surgical residency at Thorek Hospital and Medical Center in Chicago, Rep. Wenstrup established a private practice in Cincinnati and has been treating patients in southwest Ohio for more than 26 years.

Rep. Wenstrup is board certi-

fied by the American Board of Foot and Ankle Surgeons, is a member of APMA, and a fellow of the American College of Foot and Ankle Surgeons. He served as the residency director for The Christ Hospital in Cincinnati before entering Congress.

Rep. Wenstrup is a colonel in the Army Reserve. From 2005–2006, he deployed to Iraq, where he served as the podiatrist, chief of surgery, assistant deputy commander, and director of the wound care clinic with the 344th Combat Support Hospital. In addition to treating U.S. troops, the 344th was responsible for detainee healthcare throughout the Iraqi theater, with the heart of the mission taking place at Abu Ghraib Prison Hospital. Rep. Wenstrup is currently assigned to the Office of the Chief of Staff of the Army Reserve as a medical policy advisor. During his time in Congress, he fulfills his Army Reserve duties by serving at Walter Reed National Military Medical Center in Bethesda, MD.

Rep. Wenstrup lives in Cincinnati with his wife, Monica, and their son, Brad Jr.

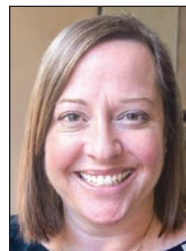
